MINUTES

APRIL 1, 2024

The workshop meeting was held at the Delmar Township building at 6 PM. Julia spoke first on behalf of Dennis Hall located on 287 as his father-in-law passed away there was a deal amongst the township supervisors that he had to remove said trailer when he passed. Due to issues, they asked for an extension to remove it when they get everything taken care of. The Supervisors agreed and appreciated he had called and notified the township.

Asked if the new setbacks were good any changes or such and the supervisors said no. Talked about the CPA and their next available time frame would be June. Questions about Route 6 being commercial and the businesses popping up without proper Zoning in residential homes and business locations. Letters will be sent out.

Up next was Joseph Hastings, Roadmaster. He started out with the trucks needing maintenance and 2-3 needs attention to the brakes because of maintenance not being tended too. 2-9 the intercooler went on it for the 4th time. Trucks are heading out for inspection, so the supervisors suggested for the garage to fix truck 2-3. Road sweeping will start to happen on Monday with the weather being a factor. The oil separation tank was put in for the new building. Tamper price was talked about for the excavator and a plate for the backhoe to interchange pieces instead of for one unit only. More ditching will continue up through Horse Thief and Hilboldt Roads. The supervisors and Joe also went over the roads for maintenance of tar and chip and oiling.
