MINUTES

OCTOBER 7, 2024

The Workshop meeting was held at 6 PM.

Ken VanSant and Misty Gardner came on behalf of the Municipal Authority. Smithville plant has had major repairs and there are more updates. Larson Design Group did a feasibility study for Stony Fork Sewer to Wellsboro Borough and the costs of fixing just the Stony Fork Sewer. Deven Martin asked for the Feasibility study to go over and see what he can find out. The Municipality also raised the rate for sewer starting in January from \$50 to \$65 with the influx of repairs and costs. Ken also asked for some assistance with their issues. Recommended next meeting putting on the Agenda for suspension of their monthly payment.

Joe Hastings, Roadmaster, updated the supervisors on the repairs to the truck and what has and will be needed. The Ford 250 received damage from an 8 pt buck and needs to be fixed.
