MINUTES

November 3, 2025

George Goldman, Emergency Management Coordinator for Delmar Township, updated the supervisors on Flood Management Services. Erb Inspection is resigning as Flood Management Services as of January 2026. Geore Goldman will be looking into who should take over the position.

Joe Hastings, Roadmaster, was informed that they will be pouring concrete for the N. Lawton bridge within the week. Tires were purchased for two of the trucks. The guys have completed 4 pipe replacements: 2 on Wolf Run Road, 1 on McKissick Road and another on Baldwin Run Road. Joey Vandergrift has been grading and should finish up this week. They guys have started leaf blowing and pushing trees out of the way. Garry Clark informed Joe Hastings of a telephone pole in the ditch on Ely Hill Road. The guys are also working on getting the trucks around for salting.

- General Municipal Pension System State Aid allocation was sent out to PSATS Pension Trust in the amount of \$11, 079.19.
- Recently Jennifer Ems completed a housing survey on Delmar Township sent out by Lisa Everett, Duncan Township Secretary. The infrastructure information is to be shared with Delta One. Instead of having each municipality contacted separately, Scott Zubek from the County GIS department has agreed to provide the information for all the participating townships. Lisa asked that each township reply to her email confirming that the township allows Scott Zubek to release the information on the township's behalf. Garry Clark motioned to release the information. Deven Clark seconded. 3-0 vote.
- Deven Martin made a motion to add to new business the hiring of Todd Stafford, \$23.00/hr. \$23.50 after 90-day probation period. Garry Clark seconded. 3-0 vote.

COMMUNICATION:

- PennDOT estimated Liquid Fuels allocation for 2026 is \$311,131.00.
- Waste Management sent their September Fee Report and payment of \$1,565.60
- Seneca Resources notified the township of the proposed drilling at the Taft 581 pad in Middlebury Twp
- LDG is requesting a time extension from December 4, 2025 to December 4, 2026 on District 3 Local Bridge Replacements Group #1 to make sure the contracts do not expire prior to getting environmental clearance.
- Received PA Municipalities Pension report for the third quarter of this year.
- Hanover Engineering working with UGI notified the township of their Sweet Briar Road Washout Project. They will be replacing an existing 2" main within the streambed of an UNT to Wilson Creek.
- Penn Dot sent a letter out informing Delmar Township of a proposed project on State Route 6, Section 166. The scope of the project is to mill and resurface the pavement starting at Colton Road to Shippen Township Line. Tentatively scheduled for spring of 2028.
- Jolie Coates, West Nile Virus Coordinator, sent out an email to all townships in Tioga and Bradford counties with her findings. In Tioga County there were a total of two mosquito samples that tested positive for West Nile: one in Elkland Borough and another in Mansfield Borough.
